2017 – Capital Budget: Transportation, Waste Management and Drainage  
Rebecca Russell, Director of Finance provided an overview of the 2017 Capital Budget summary including anticipated assessed value for the current year.

- Anderson Road West Reconstruction

- Garage Lighting Upgrades
- Woodlands Road Upgrade
- Garage Grating Upgrades

Discussion concerning reconstruction of Moulinette Island roads including design and budget ensued.
