## **Work Completed:**

- The department issued **6** building permits;
- The department carried out 79 building inspections;
- The department released 1 grading deposit;
- The department closed 10 building permits;
- The department received 3 complete permit applications;
- The department received **5** incomplete permit applications;
- The department took an average of **2** days to issue permit applications that were deemed complete at time of submission.



## **Building-Related Activities:**

- Chief Building Official (CBO) and other Township staff met to review and discuss the Township's draft Shooting Range Licensing By-law.
- CBO and other Township staff met on several occasions to review and discuss the Township's ongoing comprehensive zoning by-law review.
- Building Inspector attended virtual Joint Health and Safety Committee Part 2 Certification training. Certification was obtained.
- Building Inspector and Administrative Assistant attended separate zoning/building code-related training courses in Cornwall.
- Building, planning and by-law staff met virtually with Cloudpermit on two occasions to review and discuss ongoing software items.
- CBO and Deputy Chief Building Official (DCBO) attended Provincial Offences Act (POA) court for an ongoing Building Code Act matter.
- CBO presented at public meeting for proposed building permit-related fees and deposits amendments.
- Planning and building staff participated in first all-staff department meeting of 2025.
- CBO met with presenters and continued to prepare for the 2024 OBC Information Session February 5<sup>th</sup>.

## **Work In Progress:**

- Review and comment on planning application circulations.
- Monthly building permit statistics/information reports provided to MPAC, CMHC, Tarion and Statistics Canada.
- Staff continue to review and action open building permit and open application files. A new focus on this activity is ongoing and staff are having success in closing open files.
- Issue letters with respect to requests from lawyers for outstanding orders and open building permit files.
- Issue letters and invoices with respect to dormant permit files.
- With the release of the new 2024 Ontario Building Code, building department staff are preparing for our upcoming information session on February 5<sup>th</sup>.
