SEASONAL CLOSURE OF SIDEWALKS

To effectively maintain sidewalks over the winter, the Township determines which sidewalks will be seasonally cleared of snow and ice from November 1 - April 1. All sidewalks not identified are deemed "closed" and are not maintained.

For 2024/2025 the same sidewalks will be maintained as last year.

Under New Business, staff provided Council clarifications to the DRAFT Nuisance By-law and the ongoing public engagement.

Council directed staff to review the DRAFT by-law to ensure that the Cornwall Motor Speedway, local farmers and hunters are not negatively affected.

CYCLING INFRASTRUCTURE OPTIONS

Council received an update on the ongoing discussions with SDG Counties, St. Lawrence Parks Commission, Ontario Provincial Police, local residents, and MPP Nolan Quinn regarding potential options to improve cycling safety infrastructure in the community.

Short-term and long-term options are being investigated and qualified cycling infrastructure and safety consultants have been approached.

Options are expected for consideration in the 2025 budget.

COMMEMORATIVE OPTIONS FOR THE FORMER RAISIN RIVER HERITAGE CENTRE

Council approved a maximum financial contribution of \$51,775 to the St. Andrews Parish for the construction of a monument to commemorate the former Raisin River Heritage Centre.

The monument will be located in the St. Andrews West Cemetery south of the Parish and will be constructed using 2,500 bricks salvaged from the demolition of the former Heritage Centre. The monument will also incorporate two statues, the cross from the top of the original building, and two commemorative plaques, all of which were salvaged during demolition.

PARKS AND RECREATION GRANT APPLICATION FOR ARENA UPGRADES

Council supported submitting and application to the Community Sport and Recreation Infrastructure Fund to replace aging equipment and infrastructure at the Long Sault Arena.

If successful, the Township would receive 50% funding towards the \$723,335 project for these necessary upgrades.
